# Types of Companies

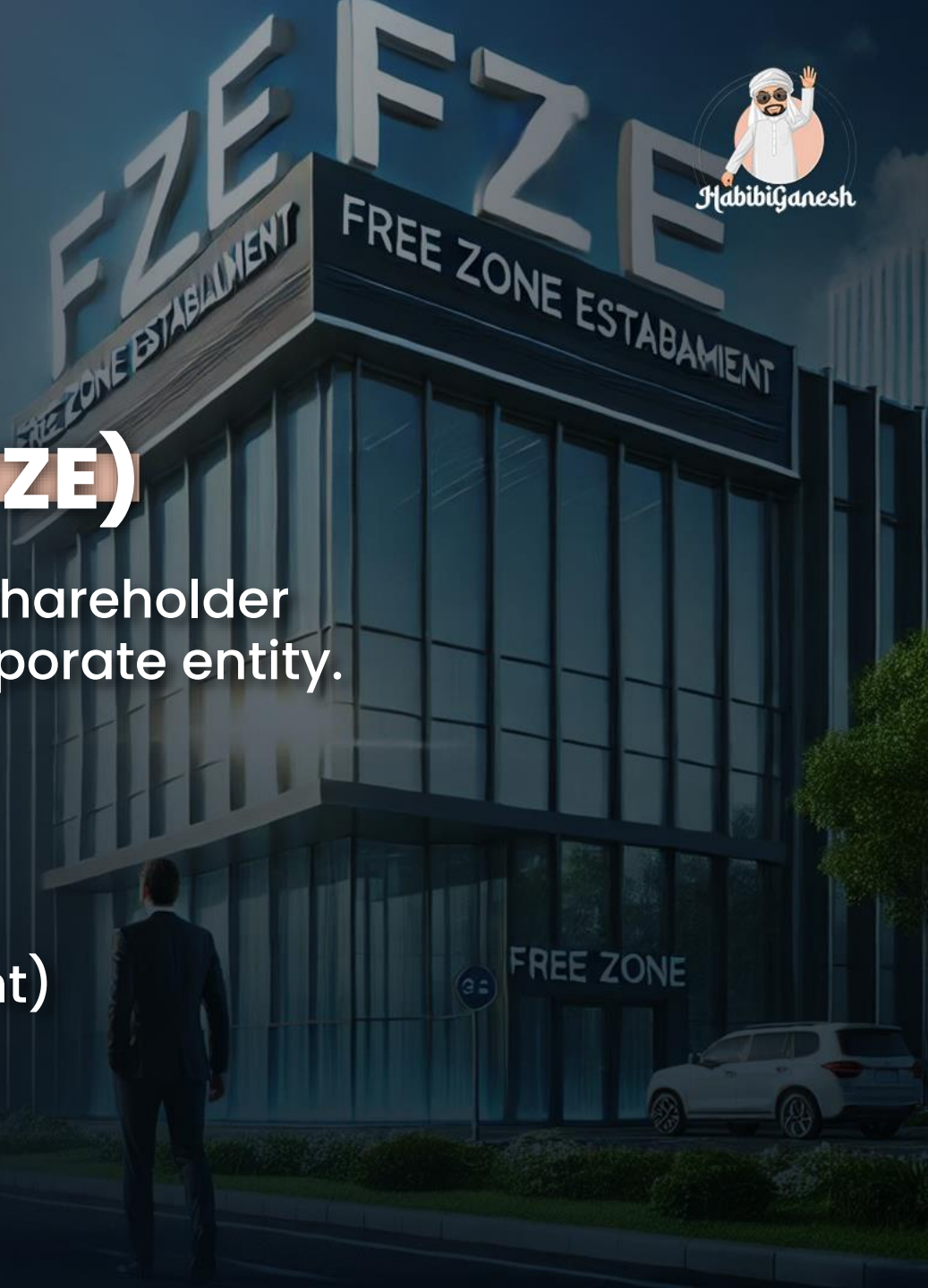


## FREE ZONE ESTABLISHMENT (FZE)

An FZE license is under the category of a single shareholder will enjoy the status of a totally independent corporate entity.

### Required Documents:

- Passport copy
- Colored photograph
- Residence visa and Emirates ID copy (if resident)
- Tourist visa / Entry stamp (If tourist visa)





# FREE ZONE COMPANY (FZC)

An FZC is a business entity with the capacity to have two or more shareholders. The name of an FZC reflects its shareholder structure.

## Required Documents:

- Passport copy (all shareholders)
- Coloured photograph (all shareholders)
- Residence visa and Emirates ID copy (if resident) (all shareholders)
- Tourist visa / Entry stamp (If tourist visa) (all shareholders)





# BRANCH OF FOREIGN COMPANY

Companies based outside of the United Arab Emirates are granted licenses under this category. The corporation will have 100% foreign ownership.

## Required Documents:

- Passport copy of the Company Manager
- Coloured photograph of the Company Manager
- Residence Visa and Emirates ID copy of the Manager (if resident)
- Tourist Visa / Entry stamp of the Manager (if resident)
- Trade License Copy (Attested)
- MOA Copy (Attested)
- Board Resolution Copy (Attested)

Foreign company document to be attested by Foreign office & UAE embassy in country of issue followed by Ministry of Foreign Office attestation in UAE

# BRANCH OF LOCAL COMPANY

A company holding a valid license from any other UAE licensing authority is eligible for this license.

## Required Documents:

- Passport copy of the company manager
- Coloured photograph of the company manager
- Residence visa and Emirates id Copy of the manager (if resident)
- Tourist visa / Entry stamp of the manager (if resident)
- Trade License copy (Notarized and Attested)
- MOA Copy / AOA Copy (Notarized and Attested)
- Board Resolution copy (Notarized and Attested)

UAE company documents to be notarized from Notary Public in UAE or attestation from license issuing authority in UAE
